Moving Crew NJ LLC ("Moving Crew NJ", "us", "we", or "our") operates movingcrewnj.com (the "Site").

Moving Crew NJ is committed to protecting online user privacy. This page informs you of our policies regarding the collection, use and disclosure of Personal Information we receive from users of the Site.

We use your Personal Information only in the manner and for the purposes described in this Moving Crew NJ Privacy Policy ("Privacy Policy.")

By using the Site, you agree to the collection and use of information in accordance with this policy.

Information Collection and Use

While using our Site, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you.

Personally identifiable information may include, but is not limited to, your name, phone number, or email address ("Personal Information").

Log Data

Like many site operators, we collect information that your browser sends whenever you visit our Site ("Log Data").

This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser type, browser version, the pages of our Site that you visit, the time and date of your visit, the time spent on those pages and other statistics.

In addition, we may use third party services such as Google Analytics that collect, monitor, and analyze this.

Disclosure of Information to Third Parties

Unless we have your consent or except as required or permitted by law, Moving Crew NJ will not sell, share, trade or give away any Information that it collects or receives regarding its Users.

Moving Crew NJ may disclose information about our Users to others if we have a good faith belief that we are required to do so by law or legal process, to respond to claims, or to protect the rights, property or safety of Moving Crew NJ or others. Moving Crew NJ may disclose information to a third party if a third party acquires Moving Crew NJ or its assets. (See *Sale or Acquisition* section below.)

Communications

We may use your Personal Information to contact you with newsletters, marketing or promotional materials and other information. You may opt out at any time.

Cookies

Cookies are files with small amounts of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a web site and stored on your computer's hard drive.

Like many sites, we use "cookies" to collect information. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Site.

Security

The security of your Personal Information is important to us, but remember, no method of transmission over the Internet, or method of electronic storage, is 100% secure.

While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

Sale or Acquisition

If another company acquires Moving Crew NJ or all or part of its assets, we reserve the right to include information among the assets transferred to the acquiring company.
